



# Westlake Girls High School

## Schedule of Fees for Westlake Girls High School 2024

A Short Term stay student is one who stays for a period less than two full terms. Students that attend school for two terms or more, will pay prorated on a full year's Tuition Fee and Administration Fee. (This must be a minimum of four weeks stay)

Tuition Fee	NZD <b>\$20,000</b> (including GST)
Administration Fee	NZD <b>\$2,500</b> (including GST)
Homestay Placement Or Designated Caregiver Monitoring Fee	NZD <b>\$450</b>  NZD <b>\$300</b>
Homestay *Special diets will incur additional costs of \$30 per week	NZD <b>\$19,000</b> per year <i>*includes internet</i> (45 weeks @ \$380 per week eg. Includes 45 weeks and a contingency fee for incidentals. Any remaining homestay fees will be refunded at the end of the study contract.
Health Insurance*	NZD <b>\$633</b> per year (*if organised by WGHS - Southern Cross)
Room Holding Fee	NZD <b>\$80</b> per week (Only applicable during Christmas vacation)
School Uniform	NZD <b>\$700</b> (approximately, depends on number of items purchased)

### Please note additional charges:

- Uniform - All Year 9-Year 13 students are in uniform. Short-term students are allowed to wear their own school uniforms or purchase a uniform if they prefer. All students must be in uniform before they can attend timetabled classes.
- NCEA Curriculum FEES\* Level 1-3 (Government determined) currently \$383.30 per year are payable extra. The students are invoiced when courses are set and curriculum to be taken are confirmed.
- Scholarship subjects\* (\$102.20 per subject) (Government determined) Top academic students may be invited to undertake these examinations.
- Requests to supply previous school records - NZD \$50 for first request (\$10 per additional copy).
- Courses (with specific equipment requirements) and sporting activities may incur additional charges.
- Items marked with \* -these services are provided by outside providers and may change. Students will be notified as soon as the latest figures are available.
- For groups - where students share a homestay - the homestay placement can be shared between the two students.
